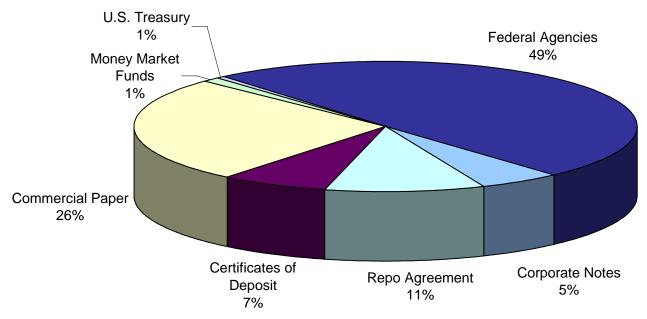

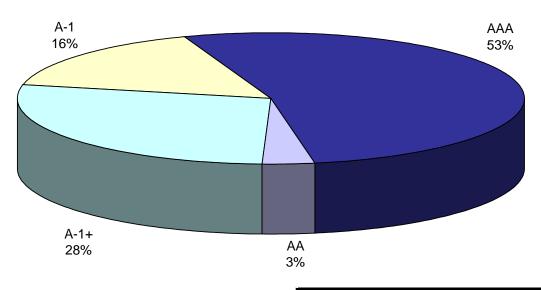
### San Bernardino County Pool Sector Distribution (as of 10/31/00)

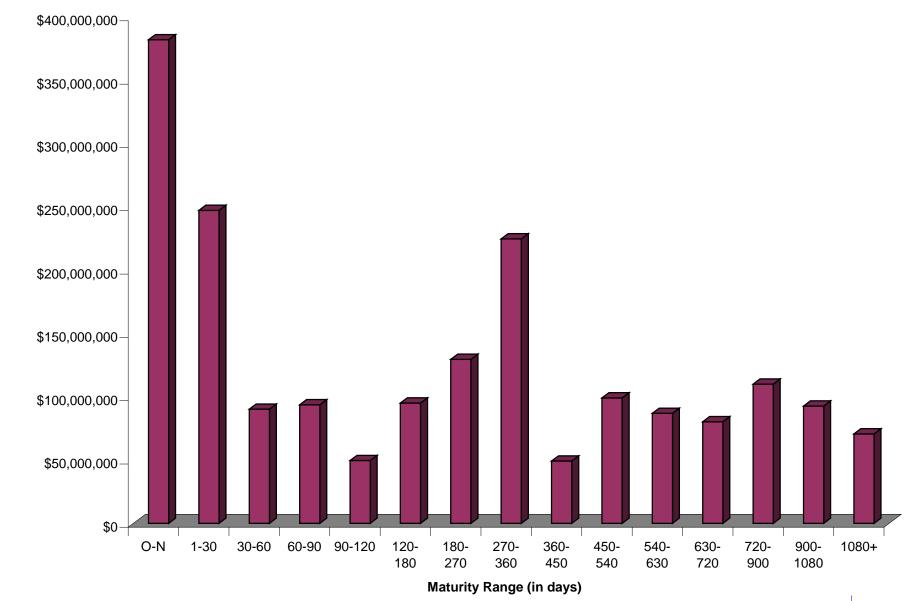
### San Bernardino County Pool Credit Quality Distribution (as of 10/31/00)
