



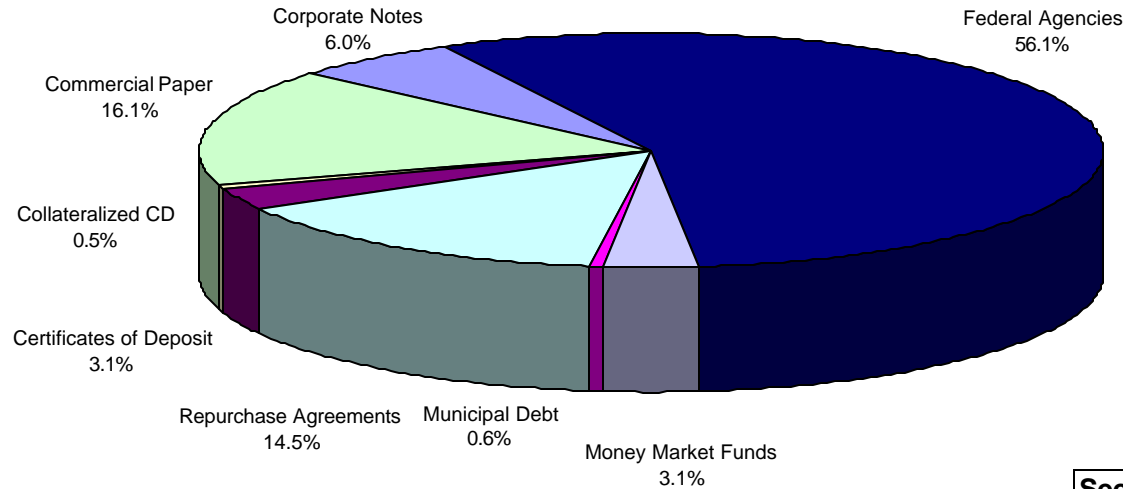

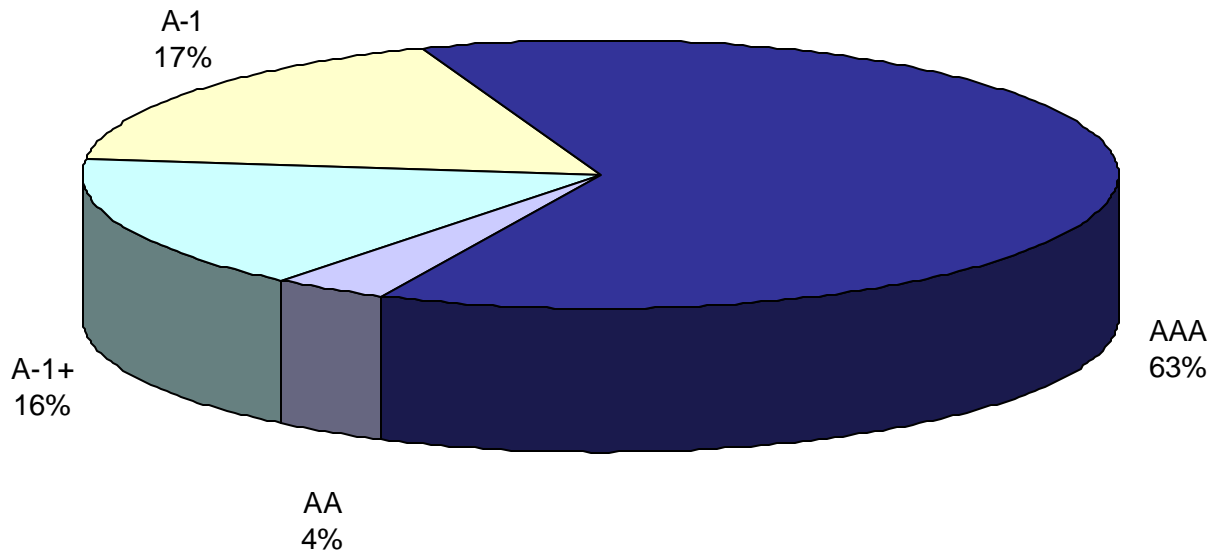
# San Bernardino County Pool Sector Distribution (as of 10/31/02)

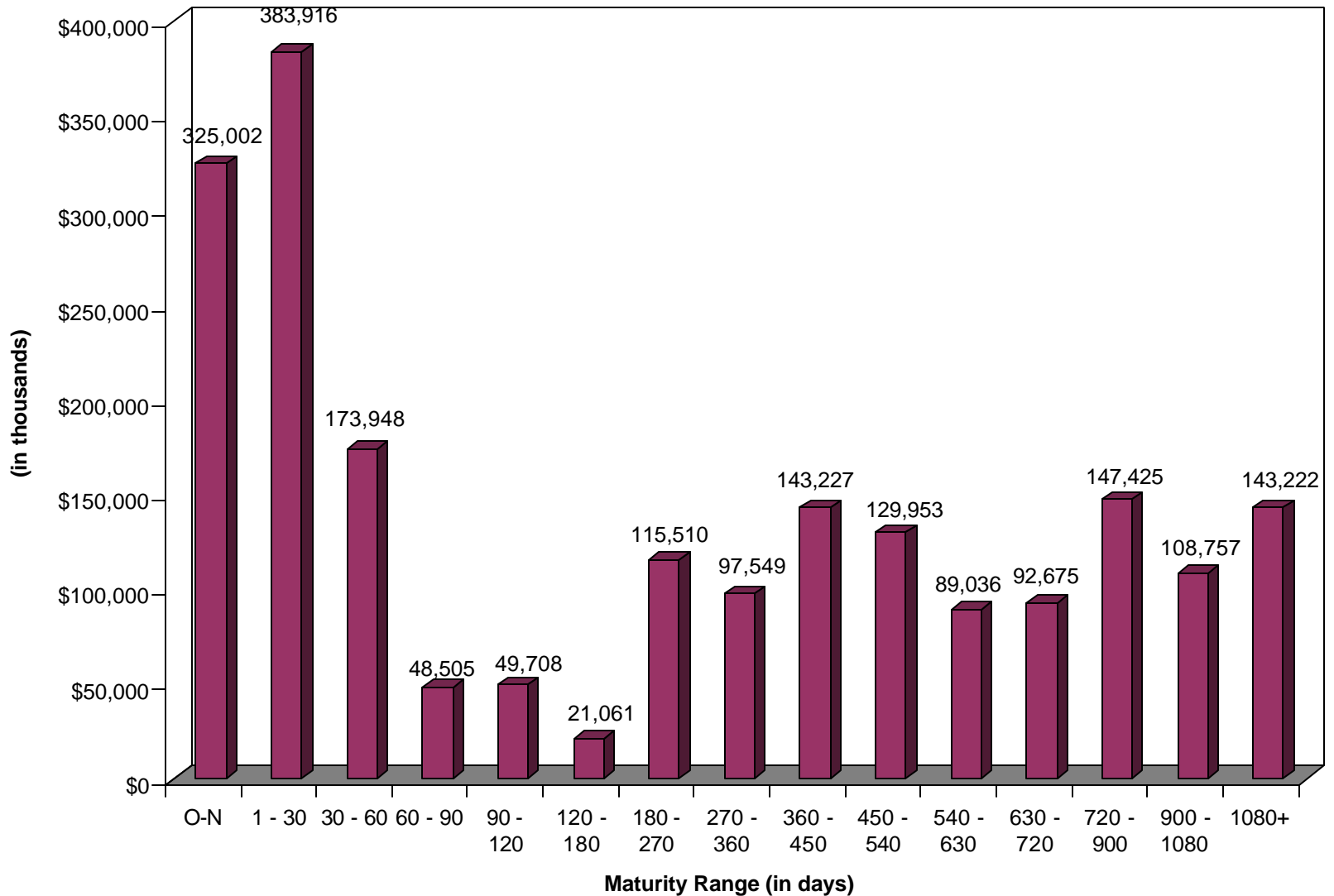
# San Bernardino County Pool Credit Quality Distribution (as of 10/31/02)
