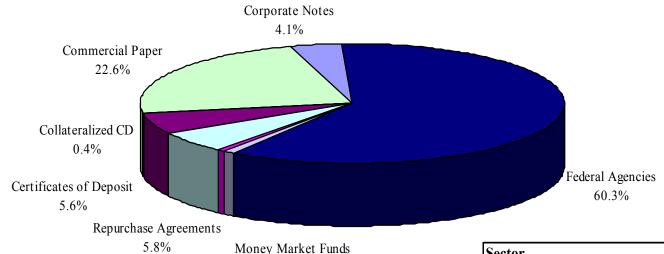

San Bernardino County Pool Sector Distribution (as of 11/30/03)



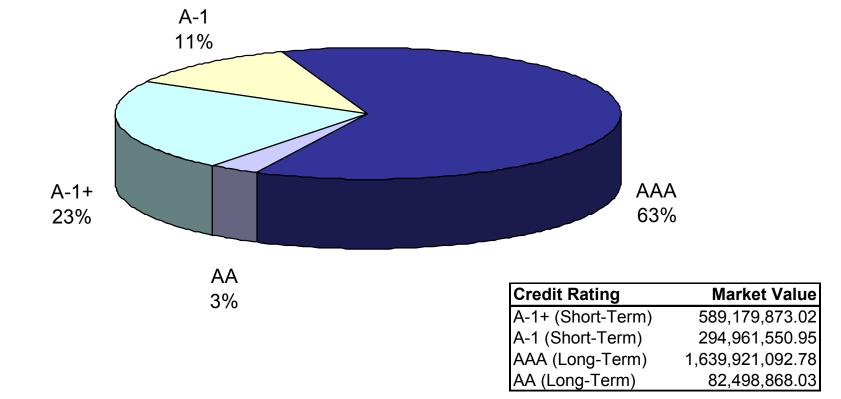

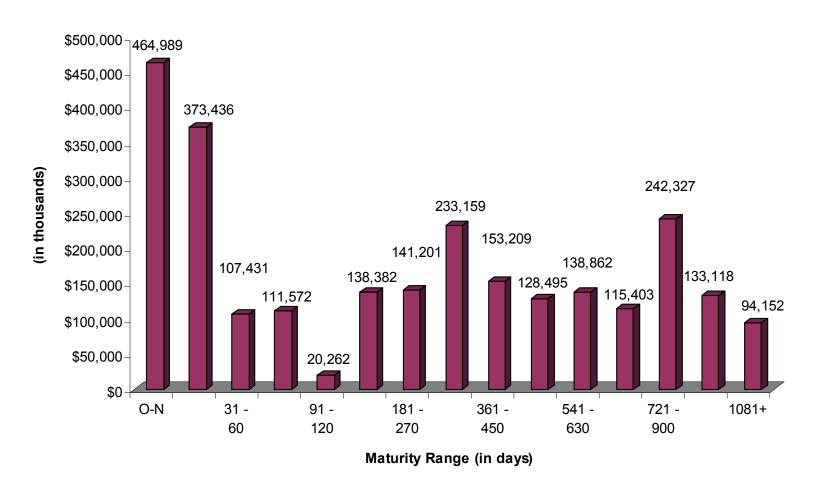


San Bernardino County Pool Credit Quality Distribution (as of 11/30/03)
