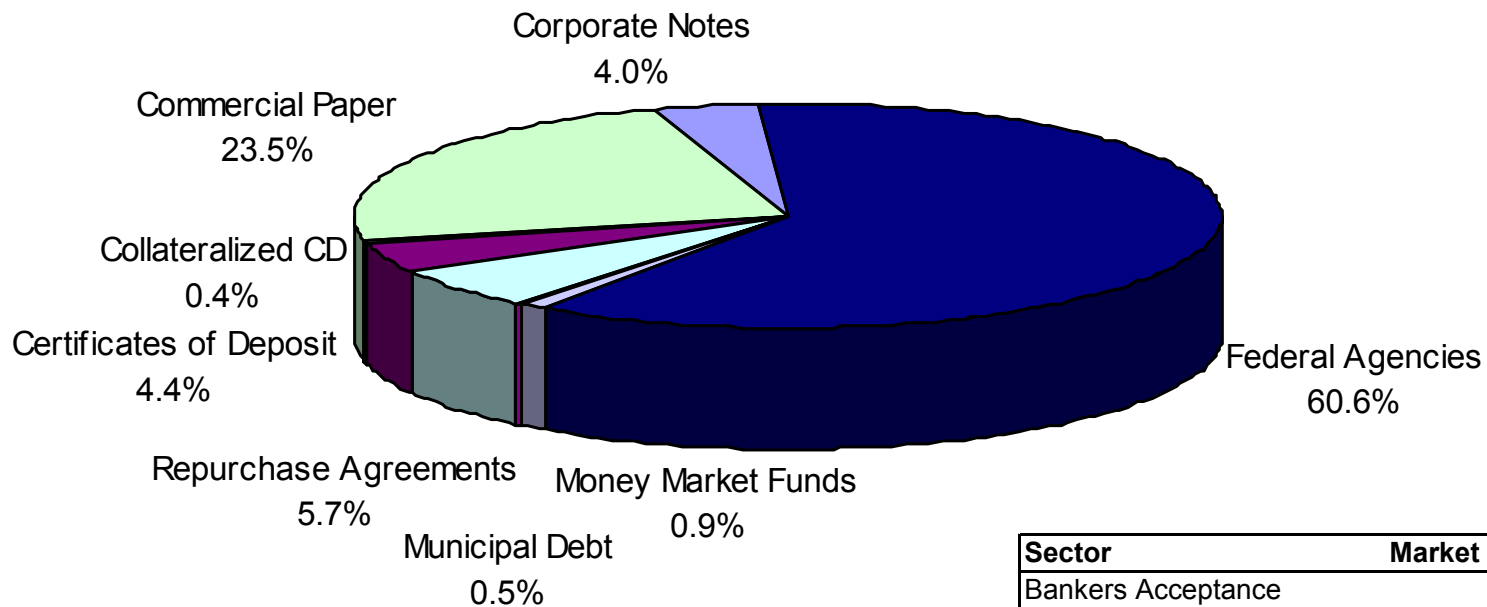

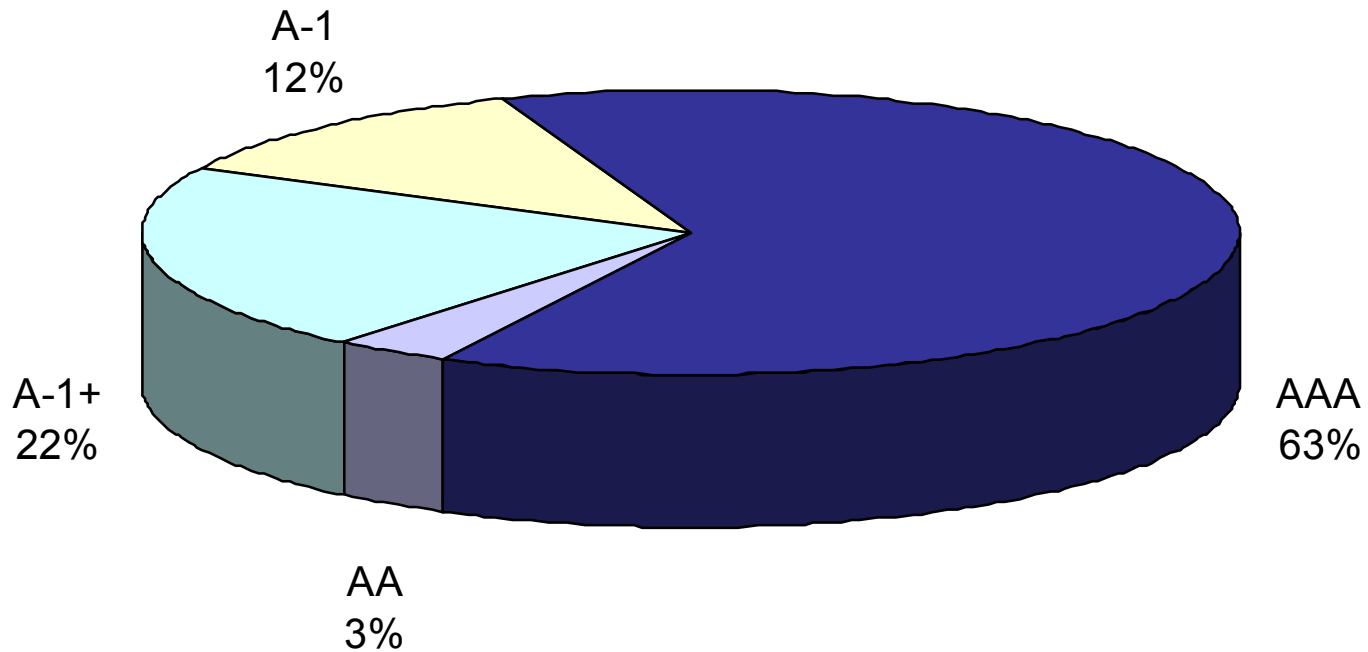

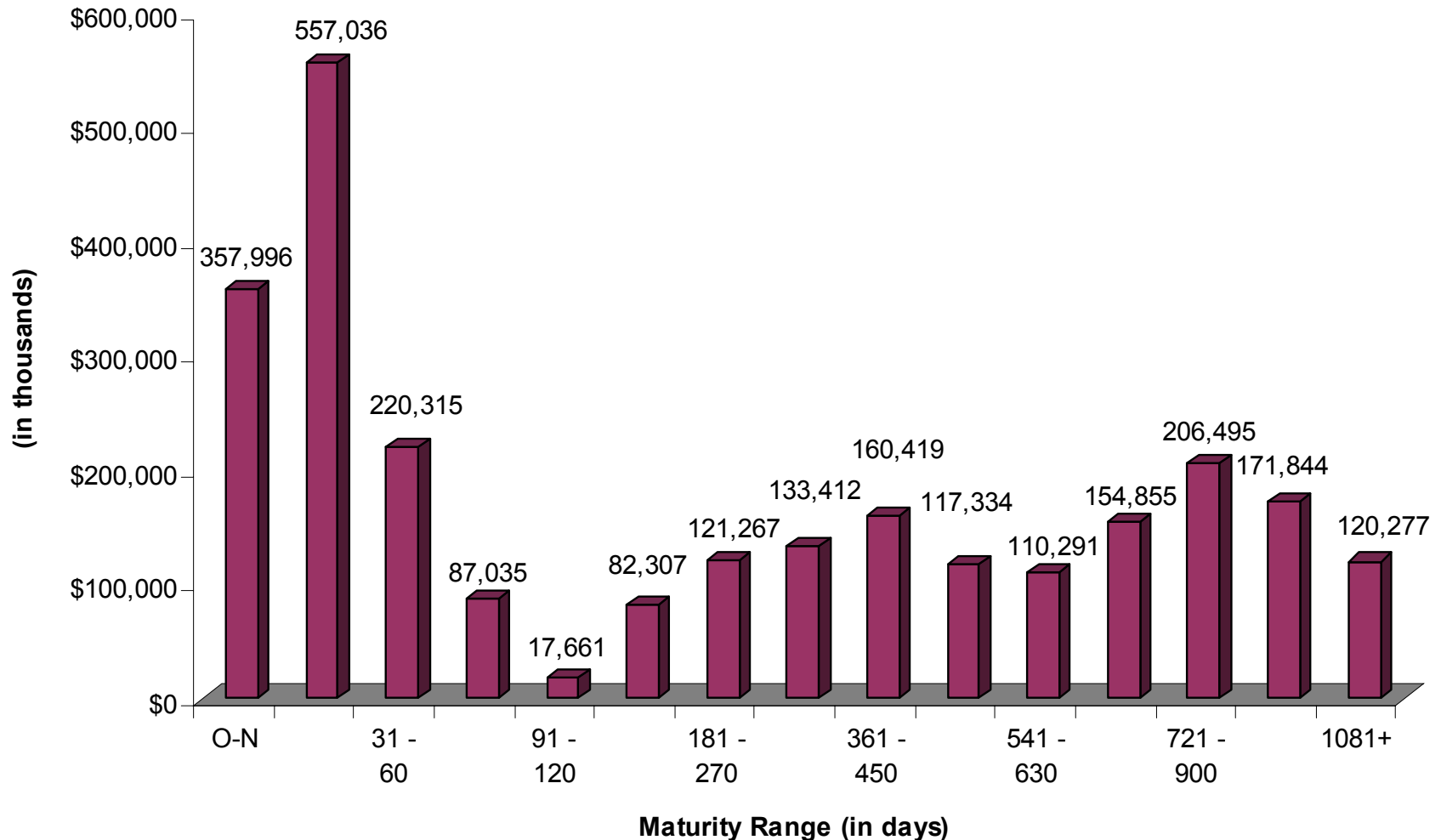
San Bernardino County Pool Credit Quality Distribution (as of 9/30/03)
