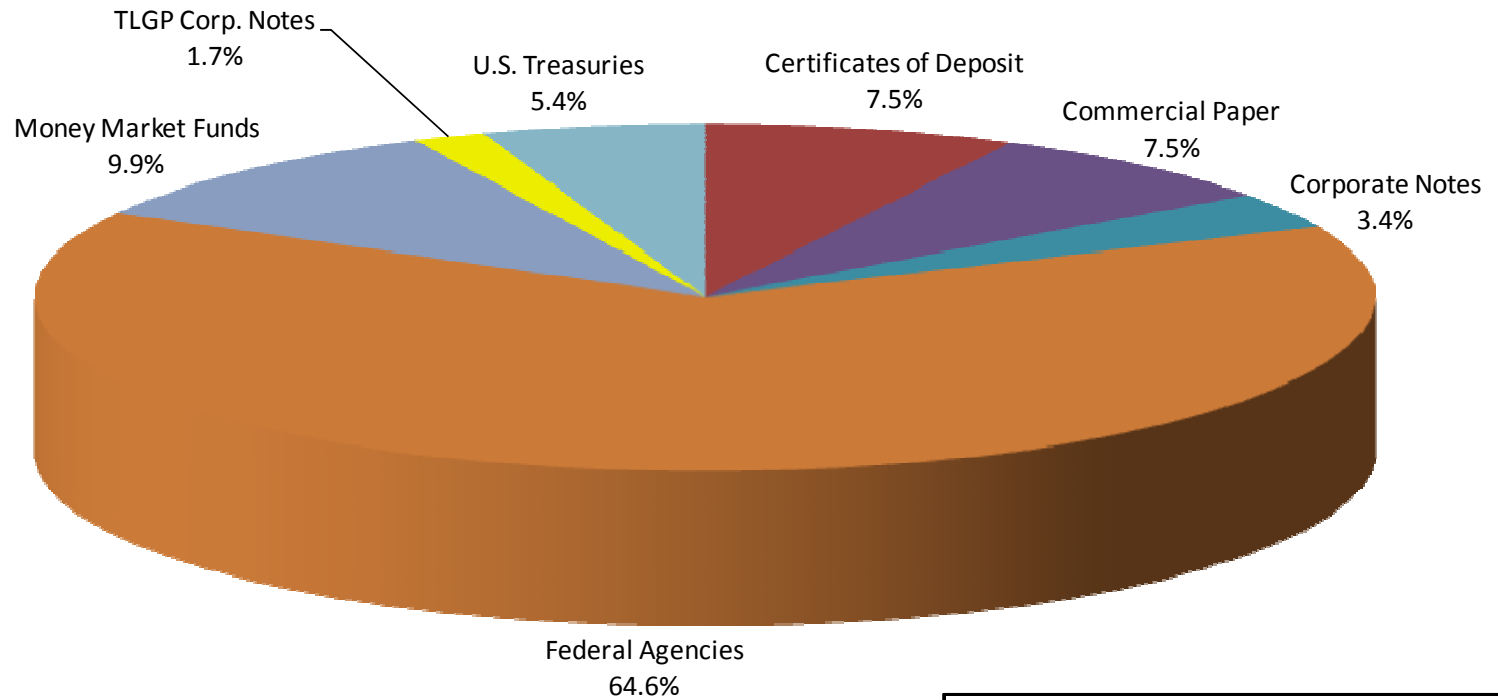

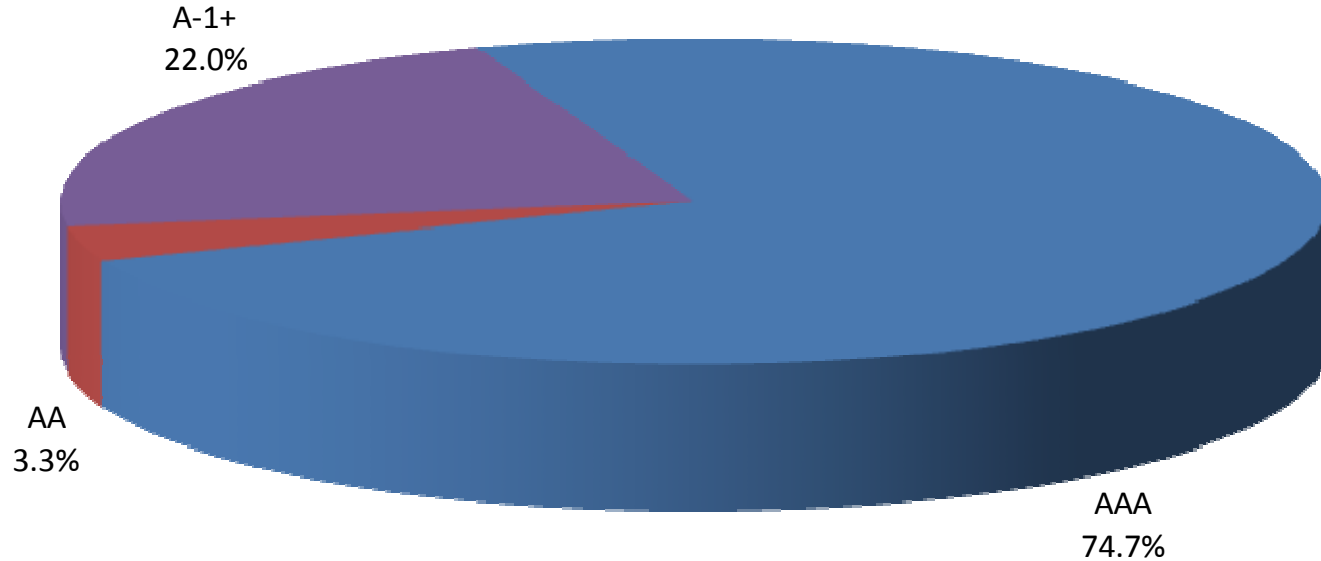
Sector Distribution (as of 7/31/09)

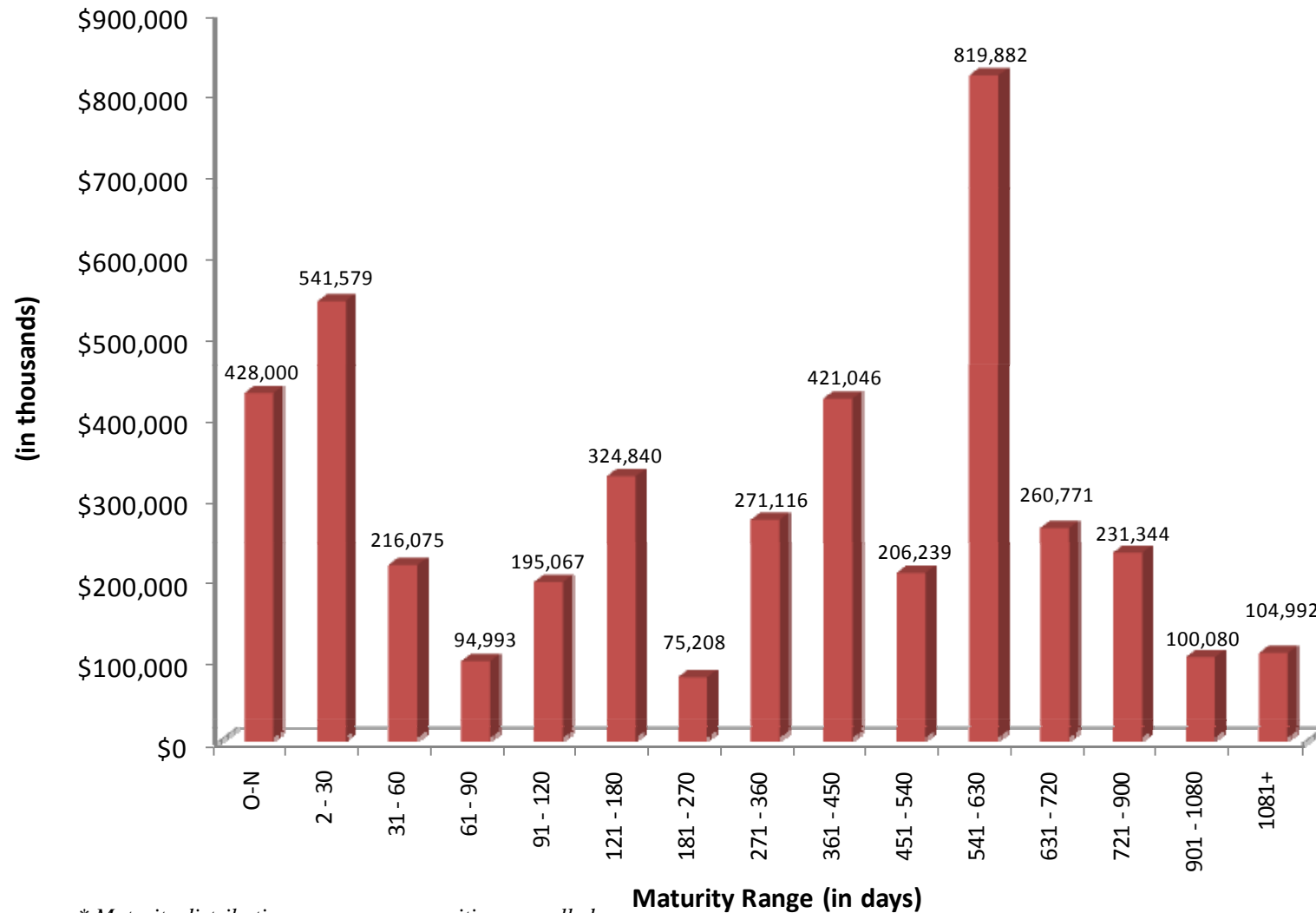
San Bernardino County Pool Credit Quality Distribution (as of 7/31/09)
