SUBJECT: REVIEW OF TREASURER'S INVESTMENTS - MARCH 31, 2010

Introductory Remarks

In accordance with California Government Code Sections 26920 and 26922, we have completed a quarterly review of the Treasurer's statement of assets in the County treasury as prepared by Public Financial Management as of March 31, 2010. In addition, we evaluated investments for compliance with California Government Code Section 53601 and the Treasurer's Statement of Investment Policy.

On February 25, 2010 the Board of Supervisors consolidated the elected offices of the Treasurer-Tax Collector and the Auditor-Controller/Recorder. As a result, the auditor, auditee, and subject matter of this report are within the same department.

Scope of Review

We reviewed selected financial transactions, procedures, and controls in effect over cash and investments. Our review was made in accordance with the International Standards for the Professional Practice of Internal Auditing issued by the Institute of Internal Auditors. These standards require that we plan and perform the review to obtain sufficient, reliable, relevant and useful evidence to achieve the objectives.

Review Results

We have reviewed the Treasurer's statement of assets in the County treasury for the County of San Bernardino, as of March 31, 2010. All information included in the Treasurer's statement of assets is the representation of the County of San Bernardino Treasurer's Office within the County of San Bernardino Auditor-Controller/Recorder/Treasurer/Tax Collector.

Based on our review, we are not aware of any material modifications that should be made to the Treasurer's statement of assets, except for certain adjustments required by GASB 31.

GASB 31 requires the fair value of investments and the changes in the fair value be reported in the financial statements. The Treasurer's Office statement of assets reports the amortized cost and fair value of its investments at March 31, 2010. Fair value adjustments are reported in the County of San Bernardino's Comprehensive Annual Financial Statements.

Cash and investments per the Treasurer's statement of assets at March 31, 2010 were \$4,779,682,840.42 reported at amortized cost. Additionally, the Treasurer's Office is in compliance with the Statement of Investment Policy and the California Government Code governing investments of local agencies.
