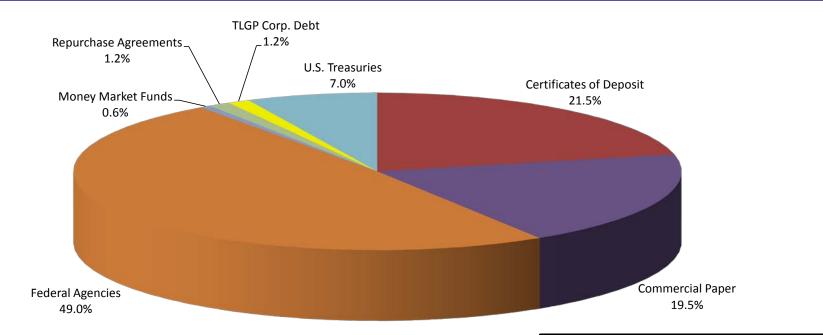

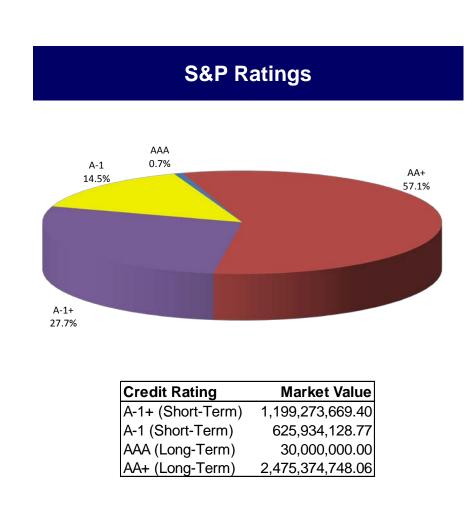
San Bernardino County Pool Sector Distribution (as of 2/29/2012)



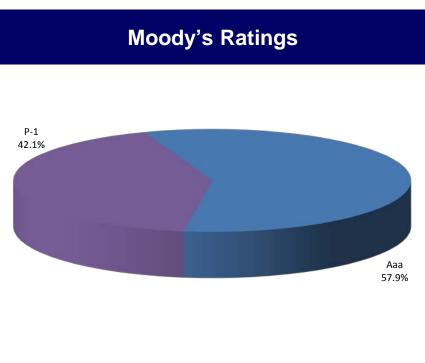

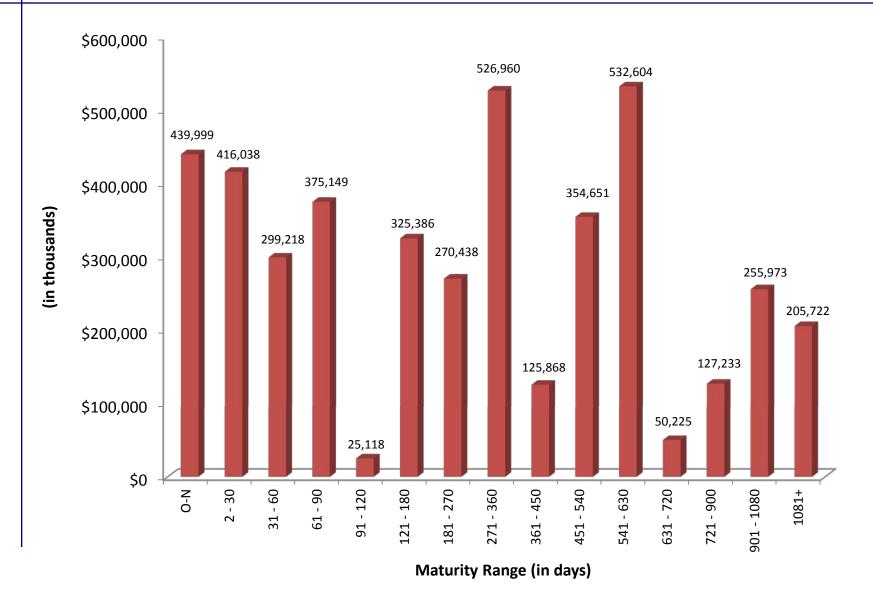
