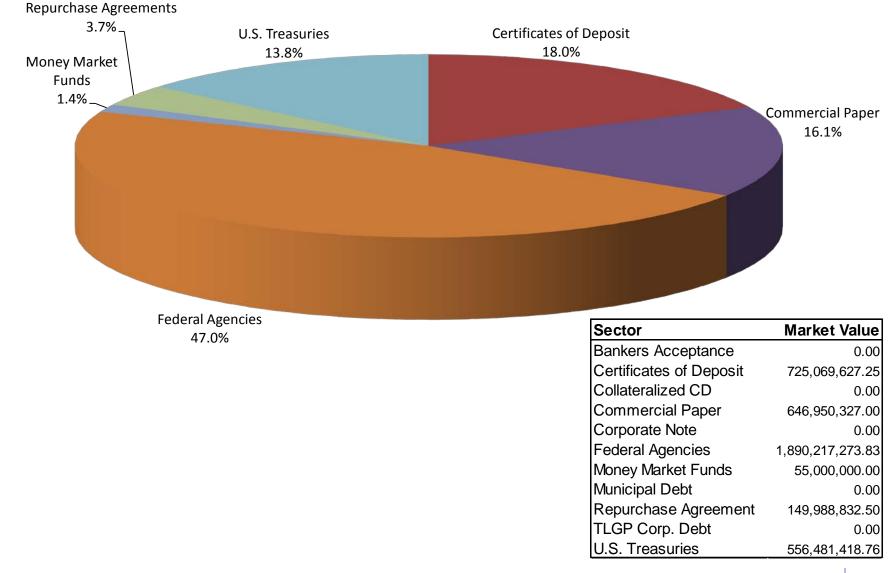

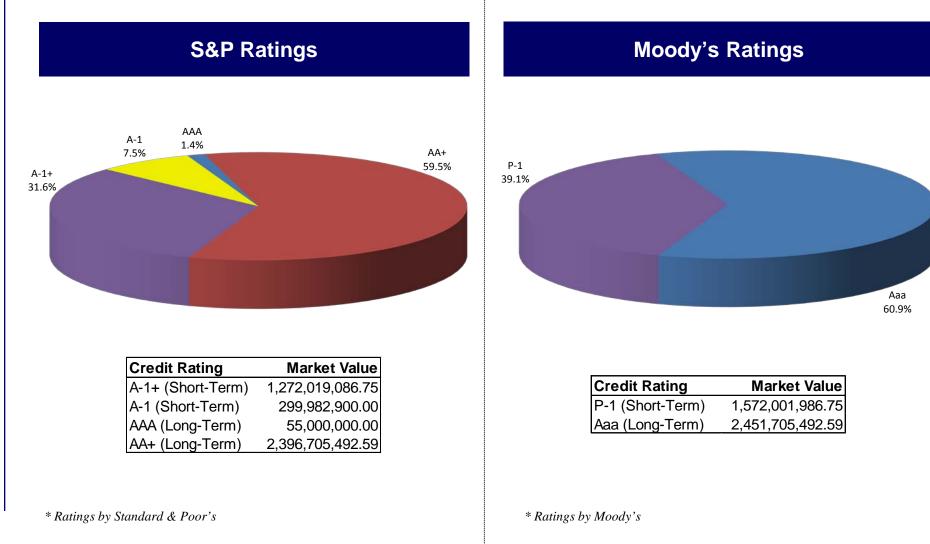


## San Bernardino County Pool Sector Distribution (as of 10/31/2012)



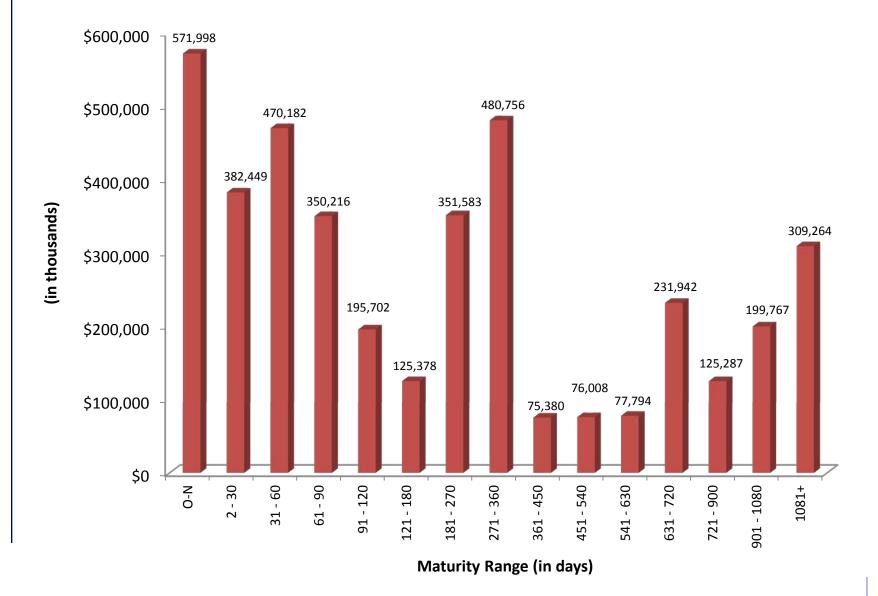


## San Bernardino County Pool Credit Quality Distribution (as of 10/31/2012)
