* Redevelopment Property Tax Trust Fund (RPTTF) apportionment dates are set by AB1484 and the collection periods are established by the Auditor-Controller/Treasurer/Tax Collector's Office to ensure compliance with the distribution dates set forth in AB1484. When the January 2 or June 1 RPTTF distribution date falls on a weekend or County holiday, the next business day is identified.

Consider this the final FY 2019-20 apportionment schedule unless legislation requires a change.
